

CHIEF INSPECTOR'S ANNUAL REPORT THE FINAL NAIL IN TR COFFIN

Hot on the heels of the devastating criticisms of TR in the National Audit Office Report published on 1 March, the Annual Report by Her Majesty's Chief Inspector of Probation published on 28 March bangs the final nail into the coffin of Transforming Rehabilitation.

Chief Inspector Dame Glenys Stacey does not mince her words when she says:

'The probation model delivered by Transforming Rehabilitation is irredeemably flawed. Above all, it has proved well-nigh impossible to reduce probation to a set of contractual requirements. Professional probation work is so much more than simply a series of transactions, and when treated in that way is distorted and diminished.'

The Chief Inspector goes on to highlight that, across both the NPS and the CRCs:

- the number of probation staff has dropped to a critical level with a national shortage, particularly of probation officers
- the profession of probation has been downgraded
- learning and development arrangements for probation are not working
- high workloads and performance targets have led to professional standards being

compromised

- probation has lost its professional leadership
- probation premises are dated, shabby and in some cases not secure
- the ICT interconnectivity between NPS and the CRS promised by the MOJ has failed to materialise
- there is no national strategy for the sufficient provision of local specialist services
- there is no coherent national workforce strategy
- there is no coherent national estates strategy

Dame Glenys also states that:

'The usual public sector governance, accountability and transparency expectations do not apply in full to the probation service. I argue that they should, to meet public expectations. Without them, public confidence is undermined.'

What the Chief Inspector makes clear is that the problems of TR are systemic and not limited to the CRCs. The split in probation she points out requires: *'...constant management attention across boundaries that are not always aligned.'*

WHAT NEXT?

Following the National Audit Office Report and the Chief Inspector's Annual Report it is very difficult to see that there is any life left in the TR model. Ministers have yet to respond to the consultation it carried out last year into its proposals to re-let the CRC contracts in 2020, so there is still time for them to reflect on the devastating criticisms

in the two reports.

UNISON believes that the plans to re-let the CRC contracts are now totally lacking in any credibility. We are calling on the Justice Secretary to do the right thing and to bring all probation services back into the public sector in a re-unified and locally run service.
