Update one: Message from Antonia Romeo, Senior Responsible Officer for the Rehabilitation Programme

I am responsible for oversight and effective delivery of the Rehabilitation programme. This means it is my role to ensure that the whole system design is deliverable and meets the Secretary of State's reform objective, and that these reforms are effective in delivering the benefits in terms of reduced reoffending.

During the consultation period I attended a number of events and heard from experts across the system on how the reforms might best be taken forward to help reduce reoffending. My team are looking carefully at the formal consultation responses so that we take full account of views in model development. We will be publishing the Government's response shortly.

I have already visited several Probation Trusts and will continue these visits to learn more about local implications of the proposed changes. For example, during my visit to Leicestershire and Rutland Probation Trust I was particularly impressed with the work the Trust is doing on the REACH project – an innovative approach to assisting offenders in to sustainable employment. This was an excellent opportunity to see the essential work probation staff do to protect the public.

I look forward to meeting more Probation staff on my future visits. If you have questions relating to the Programme, you can ask questions via the Probation Association. Update two: Probation Trust visits

Ursula Brennan, Permanent Secretary and Antonia Romeo, Director General for Transforming Justice, have been visiting Probation Trusts over the past couple of weeks. Visits have been made to Hampshire, London, Leicestershire and Rutland, Warwickshire, and Wiltshire and Gloucestershire. The visits have been extremely useful and there are plans to set up more over the coming months.

The visits have been an opportunity for Ursula and Antonia to speak to Probation staff about the impact of the Rehabilitation Programme reforms and to see any local specialist services. They have also been an opportunity for Probation staff to put their questions directly to senior Ministry of Justice officials, responsible for overseeing the Rehabilitation Programme.

Update three: Probation engagement hubs

Mike Maiden, Andrew Dawson and members of Mike's team have been running a series of Hub Engagement meetings with senior Probation staff across the country over the past couple of weeks. Representatives from all 35 Trust's attended the meetings to begin discussions on engaging with change.

In addition to this, early work on establishing a landscape assessment proforma and approach was conducted in Wales and Manchester. The purpose of this work is to help the programme team understands the local landscape which can feed into the design of the operating model. Dates have also been arranged with the remaining 33 trusts for the team to carry out landscape assessments in their area during April and May.

Update four: Launch of Justice Data Lab

The Ministry of Justice launched the Justice Data Lab on 2 April 2013. Organisations working with offenders, can now access reoffending data through the <u>Justice Data Lab</u>.

This data will provide vital information to organisations supporting the rehabilitation of offenders and will allow them to better understand the impact of their work and design more effective interventions to stop people returning to a life of crime. To use the service, organisations will need to supply the justice data lab with details of the offenders who they have worked with and information about the services they have provided. The Justice Data Lab will then supply aggregate one-year proven re-offending rates for that group, and that of a matched control group of similar offenders. The results will be provided to the organisation in a clear and easy to understand format, with explanations of the key metrics, and any caveats and limitations necessary for interpretation of the results.



Update five: Strategic Priorities for Female Offenders

On 22 March, the Ministry of Justice published the 'Strategic Priorities for Female Offenders'. The priorities sit alongside our Transforming Rehabilitation proposals, bring together the best of the voluntary, public and private sector to tackle the causes of reoffending.

The four priorities are:

- 1. Ensuring the provision of credible, robust sentencing options in the community that will enable female offenders to be punished and rehabilitated in the community where appropriate.
- 2. Ensuring the provision of services in the community that recognise and address the specific needs of female offenders, where these are different from those of male offenders.
- 3. Tailoring the women's custodial estate and regimes so that they reform and rehabilitate offenders effectively, punish properly, protect the public fully, and meet gender specific standards, and locate women in prisons as near to their families as possible; and
- 4. Through the transforming rehabilitation programme, supporting better life management by female offenders ensuring all criminal justice system partners work together to enable women to stop reoffending.
